Call to Order Chairman Hadley

Pledge of Allegiance

Chairman Hadley called the meeting to order at 6:30 p.m. in the Council Chambers of the Cranberry Township Municipal Center, 2525 Rochester Road, Cranberry Township, PA, and led the salute to the flag.

2. Roll Call

Roll call showed all Supervisors to be present. Supervisor Mazzoni was present via Skype.

3. Public Comment (Any item on or off the Agenda except for Public Hearing Items)

Robert Wright of Shady Oak Drive in Bristol creek inquired about the proposed First Energy transmission line. One of the proposals will go through his back yard, and Mr. Wright wondered what the Supervisors knew about the proposal.

Mr. Hadley said the Township found out the same way Mr. Wright did, and suggested he get in touch with Mr. Henshaw of our Planning & Development Services Department who has been looking into this project.

Public Hearings

4. PR #22888 - Forest Edge - Revised Tentative Planned Residential Dev (TLD to open PH 2/16/19)

Accept public comment on Revised Tentative Planned Residential Development Approval for a three phase, one hundred one (101) single family residential lot development located along Hope Road on 96.97 acres in the PRD/R-1 zoning districts.

Those wishing to speak were sworn in. Mr. Henshaw reviewed the plan. Virginia Loaney of Herbert, Rowland & Grubic represented the developer, and noted they are working with DEP to obtain a permit for the third wetlands mitigation.

Supervisor Hadley asked if there were modifications or waivers associated with this plan, and Mr. Henshaw answered there are none.

Public comment follows:

Anne Gill of Mirage Drive noted concerns with protecting existing wetlands and stormwater.

David Lucci, Engineer, appeared on behalf of Forest Knoll residents and discussed stormwater concerns.

Ray Huber of Mirage Drive noted that he is in agreement with Anne Gill and David Lucci and expressed concern about wildlife and water runoff.

Supervisor Skorupan requested to see a plan showing contours.

Leona Mitchell of Mirage Drive noted concern for the 100-year-old oaks in her yard.

Erma Scarfutti of Carriage Manor said that clear cutting, which was done in prior phases of Forest Edge, promotes lyme disease.

Jason Satteson requested this development not be approved in its present state.

Michael Schrock of Woodlawn Road noted speeding and traffic concerns and asked if there is a way to create an access from Vandivort Road.

Judy Hammel of Forest Knoll noted there are already water problems and when the land is cleared there will be more water problems.

Doug Matthews of Forest Knoll said he chose to live in Cranberry Township because there is thoughtful development.

Christine Smith expressed environmental, water, and traffic concerns.

Josh Pace of Forest Edge noted traffic concerns and parking at the cluster mailboxes, and asked if the fire department was consulted.

Mr. Henshaw noted our Public Safety teams review all developments in the Township.

Catherine McKee from Woodlawn Drive spoke of traffic issues and agrees with not using Vandivort Drive as a second access but would like to see a second access somehow.

Tim Janeway of Forest Edge spoke of traffic issues and needing crosswalks at school bus stops for safety of kids.

Chairman Hadley said based on the amount of testimony, he would recommend continuing the Public Hearing.
