PROJECT: GRANTS, PERMITS & REPORTS Project Manager: Lorin Meeder

Timeline: June through September 2019

Description: Schedule of Reports & Grants

Update: Water Allocation Permit Annual Report has been submitted.

PROJECT: NORTH BOUNDARY PARK DISC GOLF COURSE & TRAIL, PHASE 1 Project Manager: Lorin Meeder

Timeline: Construction - Summer/Fall 2018; Course & Trail Opening– Spring 2019

Description: CTCC 2018 Project of the Year. The project will consist of the construction of an 18-hole disc golf course. Project will also include a walking trail with amenities and an ADA accessible "Learn to Play" 6 holes disc golf course.

Update: Developing course operations and maintenance.

PROJECT: WATER TANKS – VALVE PROJECT REBID Project Manager: Lorin Meeder

Timeline: Anticipate award September; Construction – September-November 2019

Description: Replacement of the existing 16-inch manually operated valves and check valve with electrically operated valves on the West Tank modifying the operation to enhance water quality through automated operational controls.

Update: Reduced project scope to prioritize work on West Tank and South Tank as alternate. Bid opening August 20, anticipate award in September.

PROJECT: ROUTE 19 WATER LINE REPLACEMENT

Description: Replace a 60 ft. portion of water line on Route 19 across from the auto auction and visual camera inspection of approximately 700 ft. Integrity of the line suspected due to directional drilling installation of fiber optic line.

Update: Obtaining quotes, applied for HOP, anticipate work to start August 15.

PROJECT: INTERCEPTOR NO. 7 SEWER LINE UPGRADE Project Manager: Lorin Meeder

Timeline: June 2019 to May 2020

Description: A portion of Interceptor No. 7 has been exposed due to streambank erosion along Coal Run between the PA Turnpike and Rochester Road. Replacement and upsizing are recommended based on the Comprehensive Plan and future growth in the Interceptor No. 7 water shed.

Update: Investigating alternative route to avoid stream encroachment; establishing permitting, right-of-way and engineering requirements.
