TOWNSHIP OF CRANBERRY BUTLER COUNTY, PENNSYLVANIA

AN ORDINANCE OF CRANBERRY TOWNSHIP, A SECOND CLASS TOWNSHIP OF THE COUNTY OF BUTLER, COMMONWEALTH OF PENNSYLVANIA FOR THE PURPOSE OF AMENDING CHAPTER 17 ("PUBLIC & PRIVATE IMPROVEMENTS CODE") OF THE TOWNSHIP CODE OF ORDINANCES TO REVISE THE OPERATION AND MAINTENANCE (O&M) AGREEMENT, AND PROVIDING FOR SEVERABILITY AND REPEAL OF PRIOR INCONSISTENT ORDINANCES.

WHEREAS, the BOARD OF SUPERVISORS have reviewed the proposed amendment; and

WHEREAS, the judgment of the BOARD OF SUPERVISORS, such an amendment to the Cranberry Township Code of Ordinances of the Township of Cranberry, Butler County, Pennsylvania is consistent with the overall Comprehensive Plan adopted by the Township.

WHEREAS, all ordinances of the Township have been codified and all revisions to the codification appear in this document as follows: struck out for items removed and <u>underlined</u> for items added; and

NOW, THEREFORE, in consideration of the foregoing, it is hereby ordained and enacted by the authority of the Board of Supervisors of the **TOWNSHIP** that Chapter 17 Public and Private Improvements Code (PPIC) of the Township Code of Ordinances is amended as follows:

SECTION 1. Chapter 17, Attachment 7, Operation and Maintenance (O &M) Agreement is amended by revising the Agreement as attached in "Exhibit 1".

SECTION 2. Severability.

If any chapter, section, subsection, paragraph, sentence or phrase of this ordinance is for any reason declared invalid by a court of competent jurisdiction, such decision shall not affect the validity of the ordinance as a whole or any section or part thereof other than the section or part thereof so declared to be invalid.

SECTION 3. Repealer.

Any ordinance, chapter, section, subsection, paragraph, sentence or phrase of any ordinance conflicting with the provisions of this ordinance shall and the same is hereby repealed to the extent of such conflict.
