Those wishing to speak were sworn in. Comments were recorded by Stenographer, Jeanne Manko. Ron Henshaw provided an overview of the application and explained that phase 1 is the impetus of this change. The new plan will include a Sheetz, daycare and three retail establishments.

The developer's representative, Brad Simmons of Sheffler & Co., also provided the Board with an overview of the plan.

Supervisor Skorupan asked about the parking for the retail in the southern building. Mr. Henshaw explained the parking will be shared with other buildings.

When referring to the "right in, right out" from the development onto Rt. 228 & Franklin Roads, Chairman Hadley asked if there is going to be a cement structure (island) in the plan. Mr. Kratsas commented that, since Rt. 228 & Franklin are both state roads, state regulations will be in place, and these regulations do require some type of

cement structure/island.
