The Board accepted public comment on a Conditional Use application for a two (2) story, 199,336 square foot Public Education Facility to be located at 2070 Ehrman Road on 150.61 acres in the I-L zoning district.

Those wishing to speak were sworn in. Ron Henshaw reviewed the plan, noting that Virginia Loaney from Herbert, Rowland & Grubic, Inc. will give a presentation of the plan as well. Jason Kratsas discussed the roundabout noting that a third party was consulted and agreed this is the best approach in regard to traffic safety, including walkers and bikers.

Mr. Hadley noted that this is a 150-acre site and inquired as to the size of the actual footprint of the development. Ms. Loaney answered the footprint is 60 acres. Mr. Hadley then noted that leaves about 90 acres and asked if the 90 acres are in Jackson Township to which Ms. Loaney answered yes, and there are no plans at this time for development.

Mr. Hadley said he is looking at several items that still need to be addressed. Mr. Henshaw said these items are technical in nature and the Resolution will address them. Mr. Hadley stated for the record that we are aware of these comments and they will be addressed entirely.

#### **Public Comment:**

Kelly Fisher stated her family is building a home near this development and she inquired if the terrain of the 90 acres north of the school will be disturbed, and Ms. Loaney said no, not at this time.
