PROJECT: FRANKLIN ACRES SEWER LINE CONNECTION TO BREAKNECK CREEK

REGIONAL AUTHORITY

Timeline: Design - Winter/Spring 2020; Permitting/ROW - Summer/Fall 2020;

Construction - Winter 2021

Description: Install approximately 2,400 feet of sewer line, manholes, sewer meter to connect the FAPS area to BCRA and shed approximately 104,000 gallons of flow from BCWPCF.

Update: Performing appraisals for right-of-way acquisition; Engineer developing routing and design.

PROJECT: WATER TANKS - VALVE PROJECT REBID

Project Manager: Lorin Meeder

Timeline: Construction – December 2019 – April 2020

Description: Replacement of the existing 16-inch manually operated valves and check valve with electrically operated valves on the West Tank modifying the operation to enhance water quality through automated operational controls.

Update: Contractor onsite at South Tank and should be completed by March 20, cleaning and disinfection scheduled for March 24; tank should be returned to service by March 31.
