RECITALS

- A. Grantor is the sole fee simple owner of certain real property located in the Township of Cranberry, County of Butler, Commonwealth of Pennsylvania, as recorded in the Butler County Recorder of Deeds Office, the properties are identified as 130-4F108-30DA, 139-4F108-30D and 130-4F108-30F ("Grantors Property").
- B. Grantor has agreed to convey certain Temporary Construction Easements to Grantee to provide for construction of Rochester Road located through Grantor's Property.

AGREEMENT

NOW, THEREFORE, in consideration of the foregoing, and further good and valuable consideration, the receipt and sufficiency of which is acknowledged, and intending to be legally bound hereby, the parties agree as follows:

- 1. The provisions set forth above under the caption "Recitals" are hereby made a part of this Agreement as if they were fully set forth herein.
- 2. Grantor hereby grants to Grantee, a Temporary Construction Easement, including the right of ingress, egress and regress over and across the Temporary Construction Easement Area as hereinafter defined. Said Temporary Construction Easement Area being more fully described and called "Temporary Construction Easement" in the attached Exhibit "TCE Exhibit 11, TCE Exhibit 12, and TCE Exhibit 13".
- 3. Grantee agrees to indemnify Grantors for any liability for claims of bodily or personal injury or property damage relating to the Grantee's use of said Temporary Construction Easement other than for liability occurring on account of Grantor's negligence.
- 4. Upon the completion of the reconstruction / improvements to Rochester Road, Grantee agrees to restore the lawn, landscaping and trees disturbed within the Temporary Construction Easement to the condition that existed prior to the reconstruction / improvements to Rochester Road to the extent reasonably possible.

- 5. Grantors covenant that they are the sole owners in fee simple of the Grantors' Property and have the right, title and capacity to grant the Temporary Construction Easements identified herein.
- 6. All rights associated with the Temporary Construction Easements shall terminate upon the completion of the reconstruction / improvements to Rochester Road where located on the Grantor's property.




