RE: Police Vehicle Order Cancellation



I received confirmation this morning that General Motors abruptly cancelled and closed all orders for all 2021 Chevrolet Tahoe PPV and SSV models, which includes the Tahoe we ordered in January of this year. They are replacing these orders with 2022 models which will not be available until late 2021 or early 2022. Waiting for the 2022 model, which may/may not be available, is not a viable option for the Department.

I am recommending that we replace the cancelled Tahoe with a 2021 AWD Dodge Durango. This vehicle will be nearly identical to the 2020 model we took delivery of earlier this month. While smaller than the Tahoe, the Durango is less expensive and would serve our needs well.

I have attached the PACoSTARS price quote from Laurel Chrysler Dodge, Jeep, Ram for the 2021 Durango.
