**6.** Bill No. 2020-09 - Ordinance Amendment - Chapter 27 (Zoning)

Accept public comment on an Ordinance Amendment to Chapter 27 (Zoning) to provide for an additional overlay district. The Missing Middle Housing (MMH) Overlay District would provide an additional mix of housing opportunities throughout the community.

Ron Henshaw informed the Board that the Staff has heard from numerous residents with respect to the MMH Overlay. Staff has also met with numerous residents to discuss their concerns. As a result of those discussions and meetings the staff would like time to consider revisions to address concerns. At the conclusion of tonight's public hearing on this matter, Mr. Henshaw recommended the public hearing be continued to the March 25, 2021 Board of Supervisors meeting. Mr. Henshaw also encouraged residents to contact him with any concerns prior to the March 25th meeting.

Ron Henshaw informed the Board that he had received written testimony from Mr. Frank Blackstone, 2811 Rochester Road, prior to the meeting. The summary of Mr. Blackstone's testimony was in support of the MMH Overlay. (Written public testimony is attached at the end of the minutes.)

Supervisor Bruce Mazzoni stated he was appreciated the staff taking the time and effort to address the residents needs and concerns regarding the Overlay.

Supervisor Bruce Hezlep inquired about the consistency of the housing. Mr. Henshaw responded that not all housing types fit into the Zoning Overlay.

Supervisor Manipole stated that the Board appreciates comments from the residents regarding the Zoning Overlay.
