RE: Purchase Justification – Two (2) Codes Dept Ford Escape SUVs

The Department of Public Works Fleets Division has identified two (2) Codes Department 2011 Ford Escape Hybrids (Vehicles #2 & #4) as a priority for replacement. In the last year, these SUV's have experienced costly mechanical failures with a hybrid battery failure imminent (7-year life expectancy). The new hybrid battery is estimated to cost \$10,000. With the costly hybrid battery replacement, it is advantageous to replace these SUVs prior to battery failure to maximize trade in value. These vehicles also have excessive rust on body and frame.

According to the Township's Fleet Replacement Program (FRP), these SUVs are classified as Administration Vehicles with the minimum score required for replacement of 23. These vehicles are scored 29 based on age (10 years), mileage, condition, and repair maintenance cost (hybrid battery replacement. The FRP score supports this vehicle replacement. For these reasons, these SUVs were included in the 2021 Capital Improvement Plan for funding (estimated at \$55,000).

Two (2)-2021 Ford Escape AWD SUV are currently available at Laurel Automotive Group as detailed on the following page. These SUVs are assigned to the Codes Department for inspections and are recommended for replacement with the same model Ford Escape AWD, non-hybrid. The replacement will utilize the **COSTARS state contract** pricing for 2021 Ford Escape SUV's at \$24,600 each. A higher trade value was negotiated, raised from \$4,000 to \$5,000 for each existing hybrid SUV.

Due to age, mileage, condition, and cost for hybrid battery replacement, it is our recommendation to purchase two (2) 2021 Ford Escape SUVs for \$24,600 each. With trade-ins applied it lowers the cost to \$19,600 each or \$39,200 total for both, which is well under the Capital Improvement Plan estimate of \$55,000. These SUVs are assigned to the Codes Department with funding from Capital Fleet Budget **3400-6430-6122 (100%).** They are available for immediate delivery.
