Ad-Hoc Comprehensive Recreation Parks and Open Space Advisory Committee (Ad-Hoc CRPOS Committee)

**A RESOLUTION OF THE BOARD OF SUPERVISORS OF
THE TOWNSHIP OF CRANBERRY, COUNTY OF BUTLER,
COMMONWEALTH OF PENNSYLVANIA,
ESTABLISHING AN AD-HOC COMPREHENSIVE
RECREATION PARKS AND OPEN SPACE ADISORY
COMMITTEE FOR THE PURPOSE OF RECOMMENDING
UPDATES TO THE 2012 COMPREHENSIVE
RECREATION PARKS AND OPEN SPACE PLAN TO THE
BOARD OF SUPERVISORS.**

WHEREAS, in 2012, the Cranberry Township Board of Supervisors adopted the Cranberry Township Recreation and Open Space Plan dated August 2, 2012, which set forth a vision and plan for the Township's parks, recreation facilities, programming, greenways, and open spaces; and,

WHEREAS, the Board of Supervisors recognize the importance of updating the Comprehensive Recreation, Parks, and Open Space (CRPOS) Plan to provide a detailed vision for the park system, the operations of the Parks and Recreation Department, and outline a range of activities for more diverse population.

WHEREAS, the Board of Supervisors recognizes the importance to continue to monitor, adjust and improve upon the Township's Recreational programs and objectives; and,

WHEREAS, it is a goal of the Cranberry Plan to have ongoing community engagement and outreach to further the exchange of information and foster community involvement (CP Goal 10); and,

WHEREAS, the Board of Supervisors believes the creation of an Ad-Hoc CRPOS Advisory Committee may provide additional valuable insights, perspectives and recommendations with regard to recreation and open space objectives and priorities in the Township; and,

NOW, THEREFORE, BE IT RESOLVED, that the Board of Supervisors establishes an Ad-Hoc CRPOS Advisory Committee under the following conditions:

1. The Ad-Hoc Environmental Advisory Committee shall consist of a minimum 9 (nine) members to be appointed by the Board of Supervisors.
2. Members shall be residents of the Township.

3. Members shall serve in an advisory capacity and meet on as needed basis to complete its assignment.
4. The Township Manager is directed to identify a staff liaison to this Ad-Hoc CRPOS Committee who shall assist the Ad-Hoc CRPOS Committee to perform its assignment according to the intent of this Resolution.
5. The Ad-Hoc CRPOS shall submit their recommendations to the Board of Supervisors, following which the Ad-Hoc CRPOS Committee shall no longer exist as an Ad-Hoc Committee of the Township, and acknowledging the appreciation of their work by the Board of Supervisors.

NOW, THEREFORE, BE IT RESOLVED THAT the Board of Supervisors appoints the following individuals as the first appointees to the Ad-Hoc CRPOS:
