We are pleased to inform you that the County of Butler has approved your application for \$121,375.00 for the Pinhurst Drive Culvert Improvement Project submitted as part of the Southwest Butler Stormwater Planning Group. According to your application, the total project costs is estimated to be \$242,750.00. The project is funded through the County's Coronavirus Local Fiscal Recovery Funds (CLFRF).

This award is contingent upon the following special conditions:

1. Your organization must formally adopt the attached authorizing resolution no later than March 1, 2023.
2. Your organization must certify that there has been no breach in any Agreement (written or oral); payment obligation; or funding commitment to the County of Butler.
3. All engineering and/or construction contracts must be executed no later than December 31, 2023. This award shall be rescinded for all funds not under contract by December 31, 2023.
4. Your organization shall follow all requirements issued by U.S. Treasury for the CLFRF funds. Attached are the FAQs issued by the U.S. Treasury.
5. Your organization shall submit quarterly performance reports included in the attached guidance document.

6. Your organization shall execute the attached sub-recipient agreement and return to the County no later than March 15, 2023.


