11. Valleybrook Storm Sewer Upgrades

Mike Malak provided an update on each of the Initiatives.

1. Ennis Road Emergency Repair – Emergency repair work completed by Thomas Construction and Public Works.

2. Sun Valley Utilities Upgrade – Construction is complete. Engineering is working on the project closeout paperwork. May have spring restoration to complete.

3. Community Park Streambank Stabilization – Construction is complete. Final DCNR inspection was on August 29, 2023. Fifty percent of this project was funded

by a DCNR grant.

4. Fox Run Emergency Repair – Emergency repair completed by Public Works. There was a discussion about the water flow within the system.

5. Chadbourne Culvert Rehabilitation – Project complete.

6. Fox Run Stormwater Improvements – Construction underway by Thomas Construction.

7. Pinehurst Drive Culvert – Final design underway. General Permit 11 submitted to DEP. Engineering requested Authorization to Bid at the September 7, 2023 Board of Supervisors meeting. Bid will be advertised on October 8, 2023 and October 11, 2023. Bid opening is on October 24, 2023. Anticipated contract award at November 2, 2023 Board of Supervisors meeting. Project required to be under contract by December 31st per grant requirements.

8. Valerie Drive Culvert Rehabilitation – Final design completed. Temporary construction easements required for the project currently being pursued. No permits required for project. Project will be advertised for bids when easements are secured. Tim Schutzman is working with the HOA and property owner to reach an agreement.

9. Interceptor No. 7 Rehab & Streamwork – Design complete. Bid documents being prepared. Bid date being scheduled.

10.MS4 – Glen Eden Streambank Stabilization – The bid was awarded to Hunt Valley Environmental LLC. at the September 7, 2023 Board of Supervisors meeting. There was discussion about the MS4 requirements and deadlines.

2024 Projects

11. Valleybrook Storm Sewer Upgrades – Project will consist of upsizing the storm sewer system to allow additional flows to drain through the system. Project located between 113 and 115 Wyndmere Drive and extends to and along Haine School Road. Approximate length of project 500 feet.
