**A RESOLUTION OF THE TOWNSHIP OF CRANBERRY  
IN THE COUNTY OF BUTLER, COMMONWEALTH OF  
PENNSYLVANIA, ESTABLISHING THE PROPERTY TAX  
RATE FOR THE YEAR 2025.**

**BE IT RESOLVED AND ENACTED**, and it is hereby resolved and enacted by the Board of Supervisors of the Township of Cranberry, County of Butler, Commonwealth of Pennsylvania:

That a tax be and same is hereby levied on all property within the Township of Cranberry subject to taxation for the fiscal year 2025, as follows:

Tax rate for <b>General</b> purposes, the sum of on each dollar of assessed valuation, or the sum on each one hundred dollars of assessed valuation	8.03 mills .803 cents
For <b>Fire Protection</b> purposes, the sum of on each dollar of assessed valuation, or the sum on each one hundred dollars of assessed valuation	2.37 mills .237 cents
For <b>Library</b> purposes, the sum of on each dollar of assessed valuation, or the sum on each one hundred dollars of assessed valuation	1.00 mills .100 cents
For <b>Road Equipment</b> purposes, the sum of on each dollar of assessed valuation, or the sum on each one hundred dollars of assessed valuation	.85 mills .085 cents
For <b>Public Building</b> purposes, the sum of on each dollar of assessed valuation, or the sum on each one hundred dollars of assessed valuation	1.00 mills .100 cents

Pursuant to Section 3210 of the Second-Class Township Code, Cranberry Township has the authority to collect real estate taxes on a proportionate basis on properties not included in the original tax duplicate in any given year.

**THEREFORE, BE IT RESOLVED** by the Board of Supervisors of Cranberry Township, County of Butler, Commonwealth of Pennsylvania that for the year 2024 Cranberry Township will collect real estate taxes on all improved property for the proportionate part of the fiscal year remaining. The Township shall give notice of reassessments consistent with Section 3210 of the Second-Class Township Code.

That any resolution, or part of resolution, conflicting with this resolution be and the same is hereby repealed insofar as the same affects this resolution.
